SPOT ADMISSION NOTICE FOR REMAINING VACANT SEATS FOR B.TECH 1ST YEAR

In pursuance to Government of Odisha, Skill Development and Technical Education Department Letter No. SDTE-HTE-HTE-I-0003-2017/4553/SDTE, Dated.26/11/2020 for filling up of remaining vacant seats for 1st year, Spot Counseling of VSSUT, Burla will be conducted as per the following schedule.

- The following category candidates will be allowed to participate in the spot admission process of the college against vacant seats.
 - The candidates, who have not participated on earlier rounds of OJEE counseling / who have withdrawn from the OJEE counseling process.
 - The candidates who have participated in earlier rounds of OJEE counseling but have not got allotted of seats / allotted a seat but not considered further due to any reason.
 - The candidates who have been issued final allotment letter after final round of OJEE Counselling but did not report at their allotted institution.
 - Candidates from out side state with JEE Main rank are also eligible for admission into 1st year. Their fee structure will be higher than the fee structure of Odisha state students and will be as per the approval of the Government.
- OJEE-2020 rules & regulations will be followed during Spot Admission.
- All participants are required to deposit Rs.450/- as counselling fee and all selected candidate have to deposit Rs.20,000/- as part admission fee. The drafts will be made in favour of **VSSUT, Burla and payable at Burla**
- The guidelines / provisions on the eligibility criteria prescribed by the AICTE / other guidelines notified by the Government / OJEE counseling brochure will be strictly followed.
- The candidates are required to come with 10th and +2 Marksheet & Certificate (Original with self-attested Photocopy), OJEE – 2020 Rank Card (for 1st year candidate)
- The candidates are required to come with 10th and Diploma Marksheet & Certificate (Original with self-attested Photocopy), OJEE – 2020 Rank Card (for 2nd year lateral Entry candidates)
