3. Guidelines for Offline-Counselling-cum-Admission Process

- The candidates for SPOT Admission should report to the university as per the above-notified date, time, and venue at VSSUT Burla.
- Candidates are required to bring the documents (listed in section 4).
- On the date of SPOT-Admission, the candidates have to submit the filled application form along with the demand draft and other relevant documents as listed in section 4.
- At first, their documents will be scrutinized and based on the available specialization, the candidate will be allowed for the payment of the Admission fees. Details of the fees are mentioned above.
- After the online payment candidates have to take a printout of the payment receipt and deposit it at the appropriate counter. Facility for taking the printout of the payment receipt will be provided to the candidates.
- If a candidate could not able to bring one or more documents they can provide the same information in the undertaking format, enclosed (See section 6). They have to provide these mentioned documents within one month from the date of counselling-cum-Admission.
