- v. Firm should have in-house four colour sheet fed offset and other binding facilities.
- vi. Firm has to provide three possible complete design of Galaxy -2023 within 3 days and approve with two hard copies and no extension of submission date shall be entertained.
- vii. Payment will be made 20% in advance and remaining will be paid after receiving the total quantity of material.
- viii. The selected bidder shall have to submit a security deposit of Rs. 10,000/- (Ten thousand only) which is refundable after successful delivery of the consignment.
