

- 3.7 The successful bidder will submit bill in triplicate to Controller of Examinations, VSSUT, BURLA for payment. Payment will be as far as possible made within one month from the date of receipt of bill and after 100% delivery of blank answer books, after deduction of tax as per rules through A/c Payee Cheque or to be transferred to his/her account through electronic system mode.
