The sealed tender shall reach the office of the undersigned latest up to 4.00 PM of date : 22/08/2019 by Regd post /Speed post only. Tenders received beyond this date line are liable to be rejected.

Terms and Conditions:

01. Tender documents must be filled in on the attached Performa only on company letter head and must reach to this office by 22/08/2019 Under a sealed cover by registered/speed post only. Any additional information you wish to provide may be attached separately and not on the attached Performa. The Tender will be opened on dt 24/08/2019 at 12 noon hours in the office of the Registrar in the presence of Tenderer or their authorized representative, if any.
02. Cost of Tender Documents: A demand draft for Rs. 1000/- (Rupees One Thousand only) drawn in favour of VSSUT, Burla payable at SBI, Burla (Code: 2034) towards cost of tender paper must accompany the tender. Those tender without cost of tender will be rejected. The Cost of Tender Document is non refundable.
03. E.M.D The tender along with an A/C Payee D/D for the amount of @ 4% of the quoted value is to be submitted in favour of COF, VSSUT, Burla payable at SBI, Burla (code-2034) towards EMD amount.
04. Tender received after the due date & time is liable to be rejected. Tenders by FAX/ e-mail will not be entertained.
05. **The envelope containing the Tender Paper must be super-scribed as Street Light Pole Erection wok at different places of staff quarter side at VSSUT, Burla.**
06. The Registrar reserves the right to reject any or all the Tenders without assigning any reason and the decision of the university shall be final & binding.
07. The Registrar may cancel the order if it is found that the agency is black listed on previous occasions by any of the departments/ institutions/ local bodies etc.
08. **Payment terms:** a) 100% payment of the order would be paid within 30 days on completion of erection work and after getting satisfactory report from the Prof -in-Charge, Electrical Maintenance Section of the university.
09. The contractor/supplier must submit valid up-to-date GST along with bill before release of payment.
10. The Registrar, VSSUT, Burla reserves the right to cancel the work order if the equipments supplied & installed fail to meet the specifications mentioned in the order.

11. The Registrar, VSSUT, Burla reserves the right to call the firms and to conduct negotiations, if necessary.
12. Any loss/ damage during transit will be at the cost of the Firms/Contractor.
13. The Tenderers shall quote quality specifications of the Materials, unit price and taxes and other duties livable, if any on the cost separately.
14. **The Tenderers shall clearly specify Transportation charges as the poles are transported from Electrical Maintenance, of the University to Different places of Staff Quarters which is approximately 3 KM away from VSSUT.**
15. Loading & Unloading charges shall be clearly mentioned by the Firm/Contractor.
16. The period of warranty of services/replacement, if any, shall be indicated clearly.
17. All the tenders received will be opened in the presence of the tenderers/ their authorized representatives on the stipulated date. If for any reason office will be closed in the stipulated date the tender will be opened on next working day at 12.00AM.

18. The selected Tenderers shall be requires to execute the Erection & supply work within 21 days of receipt of the Work order failing which the Work order shall be liable to be cancelled.
