Post/Speed Post only.

The intending tenderers may inspect the vehicles at the University premises on any working day between 9 A.M. to 12 Noon from 1<sup>st</sup> February to 22<sup>nd</sup> February 2018.

All the tenders received will be opened in the presence of the tenderers or their authorized agents, if present at 04.00 P.M. on 23<sup>rd</sup> February 2018, which if declared a university holiday later, the tenders will be opened on the next working day as per the scheduled time. Delay in postal delivery will not be taken into consideration. The tender cover should be super scribed as "TENDER FOR VEHICLE".

Tender for each vehicle should be submitted separately but may be sent in the same cover. Each tender must accompany with the amount of earnest money (EMD) as mentioned against each vehicle in shape of account payee bank draft drawn in favour of the Comptroller of Finance, VSSUT, Odisha, Burla and payable at SBI, Burla. No tender will be considered valid without accompaniment of the earnest money. Bank drafts will be returned to the unsuccessful tenderers only after finalization of the tenders.

Normally the tender with highest offer of sale price may be accepted. But if it falls short of the upset price fixed, or is not found satisfactory, the authority may go for an open auction sale to obtain the maximum sale price.

The tenderer whose offer will be accepted by the University authority shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% within three days of issue of the intimation letter failing which the offer will be treated as cancelled and the deposits including the earnest money will be forfeited. The vehicle should be removed from the site within seven days from the date of full payment of the bid amount.

In case the vehicle/s is/are not removed, the custody and safety of the vehicle/s shall be the responsibility of the tenderer and no claim or complaint on that account shall be entertained and ground rent applicable as per University rules will be charged.

Any litigation on this sale shall be subject to the jurisdiction of Sambalpur Town only. The University authority reserves the rights to accept or reject any or all tenders without assigning any reason thereof.
