INFORMATION FOR CANDIDATES SEEKING ADMISSION TO FOLLOWING B.TECH. PROGRAMMES ON SELF FINANCING MODE THROUGH JEE-2008.

This premier college (UCE, Burla) has proposed to introduce the following B.Tech. programmes on self financing mode from the session 2008-09.

- 1) Electrical & Electronics Engineering (EEE) - 30 seats (New)
- 2) Civil Engineering - 30 seats (Additional)
- 3) Computer Science & Engineering - 60 seats (Additional)
- 4) Electronics & Telecomm. Engineering - 60 seats (Additional)

This is in line with the recommendation of BPUT, Orissa vide letter No.1080 dated 27.06.2008 and subsequent no objection from Industries Department, Govt. of Orissa vide letter No.10351 dated 14.07.2008 addressed to AICTE, New Delhi. After final concurrence from the appropriate authority, the candidates seeking admission to these four self-financing programmes will be admitted through Orissa JEE-2008 counseling being held at Bhubaneswar **as day scholar** only. At the time of admission to the above programmes the concerned students and parents' will be required to furnish an undertaking positively in the prescribed format given below which is also available at institute's website www.uceburla.ac.in. Through this notice perspective students / parents are informed that they are to make their own arrangement outside the college campus without claiming for lodging and boarding in UCE hostels.
