

Whereas

"**VSSUT**" is especially in to Skill Development and Technical Education

AND

"**CIPET**" is conducting various Skill Development Short Term Training Programmes for ITI/ Diploma/Degree Students apart from regular Diploma Programmes.

AND WHEREAS the parties wish to collaborate with each other for **Faculty Exchange Programmes/ Student Internships & Projects/ Research and Technical Activities** for a period of **TWO Years** from the date of signing of this MOU.

The Parties here to agree as follows:-





1. CIPET will offer Inplant/ Internship training to the students of **VSSUT** as per the prescribed programmes after paying the mutually agreed and subsidized prescribed fees.
2. CIPET will provide training at its premises i.e. Plot No. A, IDCO, Bampada Industrial Area, Balasore – 756056
3. The training material, schedule and curriculum will be developed by **CIPET** and the same will be finalized in consultation with **VSSUT**. **VSSUT** agrees hereunder that any training material developed pursuant to this (MOU) will be solely owned by

CIPET which shall have all the control or ownership in any form or manner whatsoever in the title, copyright or other proprietary rights to the materials, products, methodologies and deliverables developed by its employees/consultants pursuant to this "MOU".

4. Each party agrees not to issue press releases or public announcements concerning the terms of this "MOU" without the prior written approval of the other party.
5. Both parties agreed for Faculty Exchange programmes and allow to utilize the infrastructure after mutual consultation with prescribed fees.
6. **CIPET** will offer Faculty development program to the Faculties in the area of Plastics and allied as per the requirement of the **VSSUT** and after mutual consultation with mutually agreed and subsidized prescribed fees.
7. Students of **VSSUT** may utilize the **CIPET** facilities for Projects and Research related works after paying the mutually agreed and subsidized prescribed fees.
8. Both parties understand and acknowledge that they are making a significant commitment to this collaborative effort. Accordingly, parties agree to expand their best efforts on their implementation and successful continuation of the said venture.
9. **VALIDITY**

This agreement is valid for a period of **Two years** from date 05.1.2021 to 04.1.2023. Unless otherwise renewed, the agreement stands expired automatically on completion of the above period.

For any dispute arising out of this MOU between the two parties, the disputes shall be resolved amicably by mutual discussion.
