



Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

#### A STUDENT INDULGING IN RAGGING CAN BE:


- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- · Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- Collective punishment: when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.



#### ANTI RAGGING INSTRUCTIONS

FOLLOWING ACT (S) BY ANY STUDENT WILL CONSTITUTE RAGGING:-

- (A) CRIMINAL INTIMIDATION / WRONGFUL RESTRAINT.
- (B) MENTAL, PHYSICAL & VERBAL ABUSE.
- (C) INDECENT AND DISCRIMINATION BY RELIGION / CASTE / COLOUR / SEX OR PHYSICAL CHALLENGE.
- (D) UNDERMINING HUMAN DIGNITY.
- (E) FINALCIAL EXPLOITION / EXTORTION.
- (F) USE OF FORCE IN ANY MANNER I.E. DIRECT / INDIRECT.
- (G) GETTING ANY PRIVATE WORK DONE SUCH AD ASSIGNMENT OR ODD ERRANDS OR ANY PRIVATE / PERSONAL WORK.
- (H) PERSONAL DISPUTE BETWEEN STUDENTS.

#### PUNISHMENT AGAINST RAGGING:

DEPENDING UPON THE NATURE AND GRAVITY OF THE OFFENCE AS ESTABILISHED BY THE ANTI-RAGGING COMMITTEE OF THE INSTITUTION, THE HOSTEL MANAGEMENT COMMITTEE OR THE COURT OF LAW, THE POSSIBLE PUNISHMENT FOR THOSE FOUND GUILTY OF RAGGING SHALL BE ANY ONE OR ANY COMBINATION OF THE FOLLOWING:

- > SUSPENSION FROM ATTENDING CLASSES AND ACADEMIC PRIVILEGES.
- ➤ WITHHOLDING / WITHDRAWING SCHOLARSHIP / FELLOWSHIP AND OTHER BENEFITS.
- FORFEITING CAMPUS PLACEMENT OPPORTUNITIES / RECOMMENDATIONS.
- DEBARRING FROM APPEARING IN ANY TEST / EXAMINATION OR OTHER EVOLUTION PROCESS.
- > WITHOLDING OF RESULT.
- ► DEBARRING FROM REPRESENTING THE INSTITUTION IN ANY REGIONAL, NATIONAL OR INTERNATIONAL MEET, TOURNAMENT, YOUTH FESTIVAL ETC.
- >SUSPENSION / EXPULSION FROM THE HOSTEL.
- CANCELLATION OF ADMISSION.
- ➤ RUSTICATION FROM THE INSTITUTION FOR A PERIOD, RAGGING FROM 1 TO 4 SEMESTERS OR 1 TO 3 YEARS.
- EXPULSION FROM THE INSTITUTION AND CONSEQUENT DEBARRING FROM ADMISSION TO ANY OTHER INSTITUTION FOR A SPECIFIC PERIOD.
- ➤ RIGOROUS IMPRISONMENT UP TO THREE YEARS. (IN COMPLIANCE WITH THE ORDER OF SUPREME COURT OF INDIA).
- COLLECTIVE PUNISHMENT: WHEN THE PERSONS COMMITTING OR ABETTING THE CRIME OF RAGGING ARE NOT IDENTIFIED, THE INSTITUTION SHALL RESORT TO COLLECTIVE PUNISHMENT AS A DETERRENT TO ENSURE COMMUNITY PRESSURE ON THE POTENTIAL RAGGERS.
- ➤ IN ADDITION, IN CASE OF EVERY SINGLE INCIDENT OF RAGGING, A FIRST INFORMATION REPORT (FIR) WILL BE FILED WITH THE LOCAL POLICE AUTHORITIES.
- THE BURDEN OF PROOF LIES ON THE PERPETRATOR AND NOT ON THE VICTIM TO PROVE THAT RAGGING DID NOT TAKE PLACE.
