



After detailed deliberation, the following have been resolved:

- All the Government Technical Universities and Engineering/Professional Institutions/Colleges shall follow AICTE-2019 guidelines for promotion under Career Advancement Scheme (CAS).
- While scrutinizing/assessing the experience required for a candidate to be promoted to the post of Professor under CAS, a candidate must have at least three years of experience as an Associate professor in addition to his/her past experience, which should be more than or equal to fifteen (15) years along with other eligibility criteria as mentioned under the AICTE-2019 guidelines.
- For counting of past experience, existing records available with the University/Institution during the appointment of the incumbent as Reader/Associate Professor shall be taken at face value. Candidate may also submit additional experience, if any, which will be circulated in the public domain for 15 days. For verification of the same, University/Institute may also refer to the AICTE portal.
- This past experience of the candidates will be considered only for the purpose of promotion from Associate Professor to Professor under the Career Advancement Scheme (CAS) and not for any other purpose.
- The effective date of promotion for the faculty under CAS will be the next date of the last promotion of a faculty under CAS in a similar position or the actual date of promotion or the date recommended by the selection committee whichever is later.

The meeting ended with a vote of thanks to the chair.
