The interested students may avail HoR facility after making their semester registration fees deposit (if not done) and Mess Advance fees deposit through SBI, Burla / Canara (Syndicate) Bank, VSSUT, Burla Bank Challan. The boarders are required to submit the copies (Registration fees and mess advance fees) at HoR Warden Office.

The boarders need to deposit Rs. 14,000/- for UG/B. Arch. Course and Rs. 15,000/- for PG (M. Tech./ M. Sc./MCA/ Ph. D./M.Phil/ Dual Degree and Int. M. Sc.) towards Mess Advance fees in Bank account (Warden, Respective HoR) through Bank Challan.

While allowing a boarder to leave the HoR, the respective Warden shall ensure that the boarder has cleared all dues and handed over all furniture etc. to the caretaker/Matron otherwise necessary clearance should be denied. Similarly, a student shall only be allowed for admission in the newly allotted HoR on production of clearance certificate from warden of previous HoR.
