The students are required to submit the copies (HoR admission fees and mess advance fees) at HoR Warden Office at the time of reporting.


All first year M. Tech./ M. Sc/ Int. M. Sc/Ph. D boarders requested to report for HoR admission latest by 23.09.2021 positively.


