Sir,

This has reference to NBA's letters of even number dated **08-06-2017, 06-07-2020 and 05-03-2021** under which PG Engineering program offered by your Institution were granted provisional accreditation for 3+1 years by National Board of Accreditation.

2. The National Board of Accreditation (NBA) has decided that all programs which had been accorded accreditation for a period of 3+1 years (2017-21) and 3 years (2018-2021) in Tier-I/Tier II January 2013 document, will be considered for accreditation for the Academic Year 2021-22 on account of the current pandemic situation arising out of second wave of the Corona Virus and on the basis of meeting the pre-qualifiers. The data submitted by **Veer Surendra Sai University of Technology, Burla, Po. Burla Engineering College, Dist. Sambalpur -768018, Odisha** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted extension of duration of accreditation for one year. **Veer Surendra Sai University of Technology, Burla, Po. Burla Engineering College, Dist. Sambalpur -768018, Odisha** is requested to apply afresh for accreditation of the program in the new SAR Document. The application may be submitted online on e-NBA.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Veer Surendra Sai University of Technology, Burla, Po. Burla Engineering College, Dist. Sambalpur -768018, Odisha** as a whole.
