The Chairman, Institutional Academic Integrity Panel (IAIP) has submitted the report vide letter No. VSSUT/PGSR/1078/2025 dated 30.06.2025, wherein actions against three Ph.D. scholars have been recommended for their plagiarism and retraction of papers.

Similarly, the IAIP has recommended action against two faculty members for plagiarism and retraction of papers. All the above actions recommended are effective from 31.07.2025.

Resolution: The Board decided not to take the action recommended by the IAIP and instead, issue "warning letters" to all the faculty members and students involved in plagiarism and retraction of papers. Further, stringent action will be taken against them if such activity is repeated in future.
