**NOTICE**

Students are advised to follow the instructions given below for any hostel dues related discrepancies:

1. In case of **Regular Boarder**, if hostel name and amount (mess dues) is not showing in the payment gateway, then students are instructed to pay the mess dues by challan mode in their concerned hostels allotted as per the O/o No-VSSUT/DSW/726/2025 Dt: 03.07.2025 and VSSUT/DSW/731/2025 Dt: 04.07.2025 and the Regular Boarder amount which shows in the gateway through online.
2. In case of **Regular Boarder**, if the payment gateway shows **regular day scholar**, then those students are instructed to pay the regular day scholar amount as shows in the gateway through online and mess dues by challan mode in their concerned hostels allotted as per the O/o No-VSSUT/DSW/726/2025 Dt: 03.07.2025 and VSSUT/DSW/731/2025 Dt: 04.07.2025 along with that 7<sup>th</sup> and 9<sup>th</sup> sem BTech, BArch and Int.Msc students are instructed to pay Rs2800/- towards Development fees and 3<sup>rd</sup> and 5<sup>th</sup> sem BTech, BArch, Int.Msc,M.Tech,Msc,MCA students admitted during or after 2023 are instructed to pay Rs 7000/- towards Development fees in VSSUT A/c No-168 through challan mode .
3. In case of **Regular Boarder** and a **different hostel name** is showing in the payment gateway, then students can pay the amount through the payment gateway. However, they have to inform the concerned office of the Warden (of their allotted Hostel) regarding the hostel payment in other hostel.
4. In case of **Regular Day Scholar**, if hostel name and amount is showing in the gateway then students are instructed to visit office of Dean Academic Affairs for correction.
