This is for information of 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> & 8<sup>th</sup> Semester B.Tech & B.Tech.(LE) / B.Arch. and 10<sup>th</sup> Semester B.Arch. Programme students that the Semester Registration shall be conducted as per the following schedule. Note that for registration, physical appearance of the student before the concerned Teacher in-charge is mandatory.

The subject registration is not complete without signing the Registration Forms before the Teacher in-charge even if the concerned student has deposited the semester fee.

1. The payment can be done online through “Semester Registration Fee Payment” link available on VSSUT website on or before the due date. The students must ensure that the maximum limit of the debit card (If paid through debit card) is more than the amount to be paid before making payment.
2. The student shall bring three copies of the money receipt of online semester fee payment after the deposit. He / she shall retain the student’s copy with himself / herself and submit the other two copies to the concerned teacher-in-charge at the time of subject registration.
3. The names of the students who fail to pay the semester fee within the above two slots will be struck off from the roll sheet without issue of any further notice and such students will no more be considered as the bonafide student of the University. They will not be allowed to attend classes, appear the examinations and stay in any Hall of Residence.
4. The students who fail to register for the subjects within the duration given above will not be allowed to attend classes and appear any examination.
5. The students of 2<sup>nd</sup> Semester B.Tech and 4<sup>th</sup> Semester B.Tech (Lateral Entry) are required to make registration as per the following programme and they need not pay any fees.
