The subject registration is not complete without signing the Registration Forms before the Teacher in-charge even if the concerned student has deposited the semester fee.

1. The payment can be done online through “Semester Registration Fee Payment” link available on VSSUT website on or before the due date. The students must ensure that the maximum limit of the debit card (If paid through debit card) is more than the amount to be paid before making payment.
2. The student shall bring three copies of the online semester fee payment receipt after making the payment. The student shall retain one copy for his/her records, submit one copy to the concerned Teacher-in-Charge at the time of subject registration, and submit the remaining copy to the Office of the Dean, Students' Welfare.
3. The names of the students who fail to pay the semester fee within the above two slots will be struck off from the roll sheet without issue of any further notice and such students will no more be considered as the bonafide student of the University. They will not be allowed to attend classes, appear the examinations and stay in any Hall of Residence.
4. The students who fail to register for the subjects within the duration given above will not be allowed to attend classes and appear any examination.
