C. ELIGIBILITY & SELECTION PROCEDURE

1.0 Eligibility for 2-Yr M.Sc Programme :

To be eligible for admission to the 2-Year M.Sc. course, a student must have passed B.Sc./+3 Science with the proposed specialization as one of the subjects. Selection will be based on the percentage of marks obtained in the university examinations completed to date.

2.0 Selection:

The Career evaluation of candidates for the purpose of admission will be based on one of the following schemes:

Career Marks will be computed as Follows:		
High School	20 Marks	Percentage of Marks x 0.2
+2 (or equivalent) Level	30 Marks	Percentage of Marks x 0.3
+3 (B.Sc) Level Aggregate of all subjects	50 Marks	Percentage of Marks x 0.5
