OFFICE ORDER

The shifting and accommodation of Boarders for the Session 2013-14 will be as per the following instructions:

- A) The shifting of existing Boarders of Marichi Hall of Residence to Atri, Kratu and Vasistha Halls of Residence should complete on or before 10.07.2013 as per the allottement detailed below.
- B) All the 1st year B.Tech. Girls students residing in Anuradha Hall of Residence be shifted to Arundhati Hall of Residence on or before 10.07.2013.
- C) All the 3rd year (2012-13) Girl students will continue to stay in Visakha Hall of Residence, where they are presently accommodated, The 1st year M.Tech Girl students and 1st year MCA Girl students (2012-13) residing in Anuradha Hall be shifted to Visakha Hall of Residence.
- D) All the 2nd year (2012-13) Girl students will continue to stay in Arundhati Hall of Residence, where they are presently accommodated.
- E) All the 1st year B.Tech. & MCA Boys' student (2013-14) shall be accommodated in Marichi & Angira Hall of Residence except self sustaining students and the 1st year Girls' student (2013-14) shall be accommodated in Anuradha Hall of Residence. All the 1st year M.Tech and Ph.D. Boys' student (2013-14) shall be accommodated in Angira Hall of Residence and the 1st year M.Tech. & Ph.D. Girls' student (2013-14) shall be accommodated in Visakha Hall of Residence.
- F) All the 2nd year M.Tech students, those who are now staying in Marichi Halls shall be accommodated in 3R Quarters and those who are staying in Angira Hall shall be accommodated in C type quarters. All the 1st year MCA students (2012-13) be shifted to C type quarters.
- G) The Boy students of 1st year, 2nd year, 3rd year and 4th year B.Tech Self Sustaining Programme except IT Branch can not be accommodated in the University Halls of Residences due to non-availability of adequate accommodation in the campus at present. Those who are staying in University Staff quarters shall continue to stay in the quarters as available by the University.

The Wardens, Asst. Wardens and Caretakers are requested to ensure that the whole shifting process becomes smooth and trouble free affair and should be completed by 10.07.2013.
