HOW TO REACH VSSUT BY BUS

Buses are frequently running from Bhubaneswar, Cuttack, Berhampur, Baripada, Balasore, Raipur etc. to Burla and Sambalpur. The VSSUT campus is one km from Burla Bus stand and 15 km from Sambalpur Laxmi Takies bus stand (10km for the Anithapali bus stand). Autos are available frequently from Laxmi takies and Anithapali bus stop. City buses (After 6 am to 9 P.M.) are also running from sambalpur to VSSUT. Similar facilities are also available from Burla bus stop to VSSUT.

BY TRAIN

VSSUT, Burla sambalpur is well connected from Bhubaneswar, Cuttack, Rourkela, Raipur, Kolkata and other major cities by express and local trains. Sambalpur Junction railway station (10 km) is connected with VSSUT by auto and buses. Hirakud station is 3 km for VSSUT, campus.
