## RESOLUTION

The 24th September, 2018

After careful consideration, the Government have been pleased to make the following rules further to amend the Odisha Miscellaneous Certificate Rules, 2017 namely:—

### AMENDMENT

In the said Rules, following Proviso shall be inserted below sub-rule 3 Note (a)  
Provided further that

- (i) Those students who have obtained HSC or equivalent Certificate issued by competent Boards shall submit that Certificate in lieu of Resident Certificate and the local address of the educational institution will be treated as place of residence by the concerned Requisitioning Authority. For such cases, no Resident Certificate will be required.
- (ii) Those who have not passed HSC/equivalent standard and for whom HSC/equivalent Board Certificate is not available, they will obtain Resident Certificate as per rules and the said Resident Certificate will remain valid for a period of 5 years.
- (iii) The Resident Certificate will be issued as per rules to those who will take up engineering, medical, management or other professional courses and for them, such Certificate will be valid for a period of 5 years.
- (iv) Resident Certificates as per rules will be issued in connection with any Government job as per conditions of the Requisitioning Authority and the same will be valid for 5 years.

2. The sub-rule 5 of rule 6 will be amended as follows:—

- (a) The validity of Resident Certificate shall be five years from the date of issue.
- (b) The Validity of Income Certificate shall be three years from the date of issue whereas Legal heir and Guardianship Certificate shall be permanent in nature unless modified or cancelled by orders of Competent Authority. The Certificate issued by the Revenue Officers under these rules shall be accepted by all requiring authorities.

This will come into force from the date of publication in the *Odisha Gazette*.

#### ORDER

Ordered that this Resolution be published in an Extraordinary issue of the *Odisha Gazette* and copies should be supplied to all Departments / all Heads of Departments / all R.D.Cs / all Collectors / all Sub-Collectors / all Tahasildars.
