The boarders need to deposit Rs. 14,000/- for UG Course and Rs. 15,000/- for PG (5 Year Dual Degree & Int. M. Sc./Ph. D) towards Mess Advance fees in favour of the Bank account (Warden, Respective HoR) through challan.
