NOTICE

In pursuance to Govt. of Odisha letter no. SDTE-HTE-HTE-II-0086-2021/1128/SDTE, Bhubaneswar, dated 10.03.2022 SDTE Department, Dual degree (Integrated B.Tech. and M.Tech. Programme) currently running in the Dept. of Civil Engg. & Electrical Engg. is to be closed with effect from next academic session 2022-23. No admission will be taken in both of these two courses mentioned above. However, as per above Govt. order, the students studying in 1st, 2nd, 3rd and 4th year have the option of exiting the programme with B.Tech. Degree after completion of 4 years in the existing programme.

The students opting to exit the programme have to submit their consent in the form given at Annex-1. In addition, they have to submit an undertaking in the form of a Court Affidavit in original on non-judicial stamp paper of Rs. 10/- as per the format given in Annex-2. The last date of submission of the consent form and course affidavit is 15th April 2022 to the respective HODs.

The students opting to exit the programme after 4 years have to fulfill all the academic requirements, course and credit requirements until 4 years of dual degree programme. No change in option shall be considered once consent is submitted by the applicant through their parents.

Students who want to continue their 5-year dual degree programme must not submit the consent form.
