4. Guidelines for Offline-Counselling-cum-Admission Process

- The candidates on the merit list should report to the university as per the abovenotified date, time, and venue at VSSUT Burla.
- Candidates are required to bring the documents (listed in section 5).
- On the date of Counselling-Cum-Admission, the candidates will be called as per the merit list.
- At first, their documents will be verified and then a link will be provided for the payment of the Admission fees. Details of the fees are mentioned above.
- After the online payment candidates have to take a printout of the payment receipt and deposit it at the appropriate counter. Facility for taking the printout of the payment receipt will be provided to the candidates.
- If a candidate could not able to bring one or more documents they can provide
 the same information in the undertaking format, enclosed (See section 8). They
 have to provide these mentioned documents within one month from the date of
 counselling-cum-Admission.
- If a candidate fails to report on the date of counselling-cum-Admission, then the
 candidate will lose the claim over the seat and the same seat will be available for
 the next eligible candidate.
