No.1902081046, IT 8 <sup>th</sup> semester	Rusticated from the University for one-year with effect from 11.01.2023 and are imposed a financial punishment of Rs.25,000/-(Rupees twenty-five thousand) only each and they need to submit the sum by 20 <sup>th</sup> January, 2023 to account of their respective Hall Development Fund. Their registration stands cancelled from the even semester i.e. January – April, 2023. They are not allowed to enter into the Hall and university premises and violation of the imposed punishment will lead to termination of their studentship from the university. If any indiscipline found subsequently, their studentship will be terminated and they need to submit an undertaking with their parents without fail at the time of reporting to the university after the punishment period.  Imposed a financial punishment of Rs.25, 000/- (Rupees twenty-five thousand) only each and they need to submit the sum by 20 <sup>th</sup> January, 2023 to account of their respective Hall Development Fund failing which they will not be permitted to continue their semester and the registration will stand cancel. If any indiscipline found subsequently, their studentship will be terminated and they need to submit an undertaking with their parents without fail.
