#### CORRIGENDUM

## Exemption from 360° degree feedback for two academic sessions viz. 2019-20 and 2020-21

This Corrigendum is being issued with reference to Circular No. 27/T&LB/Pay/01/2022-23/58 (Dec.) dated 07.07.2023. In AICTE Gazette Notification dated 1<sup>st</sup> March 2019, the 360° feedback is mandatory requirement for promotion of incumbent faculty members. Some of the Institutes could not implement 360° degree feedback mechanism for academic sessions 2019-20 and 2020-21 due to COVID-19 pandemic situation, following to which this Council has received representations from faculty members seeking exemption from 360° degree feedback for promotion under 7<sup>th</sup> CPC for two academic sessions viz. 2019-20 and 2020-21.

The above issue was placed before the committee of experts for deliberations and the committee after detailed discussion has recommended that only the two academic sessions viz. 2019-20 and 2020-21 may be exempted from 360° degree feedback as prescribed vide AICTE 7<sup>th</sup> CPC Regulations 2019.

All the AICTE approved Institutions are requested to comply with the above.
