

**RESOLUTION**

**Subject: Guidelines for Financial Assistance Scheme under Mukhyamantri Medhabi Chatra Protshan Yojana (MMCPY) for (A) meritorious ST and SC students prosecuting higher study in National Level Institutes/ State Government run Medical & Engineering Institutes (B) One time financial assistance to ST/SC students from economically deprived backgrounds pursuing general (+3) degree course in any Government Institution within the State.**

**Title of the Scheme:**

The scheme shall be known as “**Financial Assistance Scheme under Mukhyamantri Medhabi Chatra Protshan Yojna (MMCPY) for ST and SC students for Higher Education**”

**Objective:**

The objective of the scheme is to

- a. Recognize and promote meritorious Scheduled Tribe/ Scheduled Caste students for completing their education in National Level Institutes/ State Government run Medical & Engineering Institutes by providing financial assistance from state budget.
- b. Provide one time financial assistance to needy ST/ SC students from economically deprived backgrounds pursuing general (+3) degree course in any Government Institution within the State on case to case basis.

**Background:**

Education is the strongest medium for empowerment of any community and more so for historically deprived Scheduled Tribe & Scheduled Caste communities. Importance of education as a means of advancement of capacity, well-being and opportunity for these disadvantaged communities is uncontested. Thus, improving educational status of scheduled tribe and scheduled caste

communities had been the topmost priority in policy planning and development efforts of the State Government.

While ST & SC Development, M & BCW Department is implementing usual Post-Matric Scholarship Scheme, the entire application and sanctioning process takes its due time. Further, amount admissible under Post-matric scholarship is limited as per approved capping of fees & maintenance allowance for different courses which many a times remain short of actual requirement by the students to meet the urgent requirement of securing admission to the course and completion of the course. There were instances in past where very needy ST/SC students faced difficulty for arranging even the basic minimum amount to secure admission with their limited financial resources. These apart, students have to incur other incidental expenses for study like purchase of books/study materials, coaching/ tutorial expenses which is not covered under Post-matric scholarship amount. In such situations, ST/ SC students from economically deprived backgrounds face hardship in realising their dream of higher education and better future.

In order to help such needy and meritorious ST/ SC students, Government of Odisha will extend financial assistance from state budget under *“Financial Assistance to Students pursuing studies in National Level Institutes/ Colleges and State Level Govt. Institutes/ Colleges”* to eligible ST/ SC students in (a) National Level Institutes/ State Government run Medical & Engineering Institutes and (b) needy ST/ SC students from economically deprived backgrounds pursuing general (+3) degree course in any Government Institution within the State. The scheme would benefit ST/SC students to take admission and complete their general/ professional/ technical course and would contribute to higher educational attainment among them.

#### **Scheme Details:**

***(A) Financial Assistance for meritorious ST and SC students for Higher Education” in National Level Institutes/ State Government run Medical & Engineering Institutes.***

Under this component, State Govt. of Odisha will provide financial assistance to poor ST and SC students who have secured admission/ are continuing their higher studies in National Level Institutes/ State Government run Medical & Engineering Institutes in order to enable them to complete their

higher education.

For eligible ST/SC students under this component, full tuition fee and non-refundable charges, including hostel admission charges, mess charges etc. for securing admission into the course will be covered under Financial Assistance Scheme. The expenses towards books and other expenses incidental to studies along with living expenses will be covered on case to case basis under due approval of the Head of the Department.

For subsequent years of study for the particular course, student will be covered under regular Post-Matric Scholarship Scheme through Odisha State Scholarship Portal (OSSP). In event of requirement exceeding the maximum capped limit under Post-matric Scholarship Scheme, in subsequent years, the differential requirement will be met from Financial Assistance Scheme, on case to case basis, with approval of the Head of the Department.

***(B) One time Financial Assistance for ST and SC students from economically deprived backgrounds for pursuing general (+3) degree course in any Government Institution.***

Under this component, State Govt. of Odisha will provide a one-time financial assistance to the maximum extent of Rs.50,000/- (Rupees Fifty Thousand Only) to eligible ST and SC students, on case to case basis, for pursuing general (+3) degree course in any stream in any Government College within the State. Application for extending financial assistance under the scheme will be recommended by the District Collector considering the financial hardship/ distress condition of the family. District Welfare Officer will ascertain the quantum of one-time assistance required to facilitate the student to complete the full course in the given institution. The DWO will forward the sanctioned amount to the Department for disbursement to the applicant.

**Eligibility criteria:**

- Students should belong to Scheduled Tribe/ Scheduled Caste community.
- Students Shall be a permanent resident of Odisha.
- The annual income of the family of the ST or SC students from all sources should not exceed Rs.1,00,000/- (Rs. One Lakh) only per annum.

- For Component (A), students should have secured/ taken admission for higher study (after class 12th) in institution of National Level or State Government run Medical and Engineering College in any professional or technical course.
- In case of component (B) students shall be pursuing/ secured admission for general (+3) degree course in any stream in any Government Institution within the state.

**Documents required:**

- Caste Certificate issued by competent authority.
- Income Certificate issued by competent authority.
- Copy of matriculation certificate and mark-sheet.
- Copy of intimation/ selection/ allotment letter from concerned institution/ entrance exam conducting body/ testing agency.
- Copy of first page of bank account (Aadhaar Seeded Bank account)
- Course fee structure/ details of the concerned institution.
- Details of other incidental expense requirement for purchase of books/ study materials, coaching/ tutorial expenses etc.

**Funding:**

Total expenses under the scheme will be met from the state budget. Under component (a) first time full requirement towards tuition fee and non-refundable charges, including hostel admission charges, mess charges etc. for securing admission into the course will be met from Financial Assistance scheme. From subsequent year till completion of the course, student will be covered under regular Post-Matric Scholarship scheme and the differential requirement, if any, will be met from Financial Assistance Scheme. Under component (b), one time financial assistance will be extended to eligible students over and above their entitlement under regular Post-matric scholarship scheme.

**Operational modalities:**

***(A) "Financial Assistance for meritorious ST and SC students for Higher Education" in National Level Institutes/ State Government run Medical & Engineering Institutes.***

- Any eligible ST/ SC student who have secured/ taken admission for higher study (after class 12th) in institution of National Level or State Government run Medical and Engineering College (list attached at Annexure-A) in any professional or technical course can make application to District Collector/ District Welfare Officer of the domicile district for receiving financial assistance under the scheme.
- Upon receipt of application, District Welfare Officer shall immediately facilitate registration and application of the student in Odisha State Scholarship Portal. Student need to upload all required documents in portal.
- The application submitted by student will flow in DWO login for verification and sanctioning. The DWO will verify the eligibility documents, document confirming selection of student in concerned institution/ entrance exam conducting body/ testing agency beforehand to ensure the eligibility under the scheme.
- DWO will refer the course fee structure of the institution submitted by student and shall ascertain the total financial assistance amount requirement by taking into account the admission fee, yearly tuition fee and other non-refundable charges, hostel admission charges, mess charges and any other charges required for securing admission into the course. Wherever required, DWO shall make direct contact with the institution concerned for any clarification on the requirement of amount for admission and completion of course for particular academic year.
- DWO will sanction the amount in OSSP which will be disbursed directly by the department in student's bank-account in DBT Mode. The student shall endeavour to seed his/ her bank-account with Aadhaar for hassle free payment.

- For subsequent years of study for the particular course, student will be covered under regular Post-Matric Scholarship scheme. In event of requirement exceeding the maximum capped limit under Post-Matric Scholarship Scheme, the differential requirement will be met from Financial Assistance Scheme.
- *In case of any exigency for immediate payment to eligible ST/SC student to secure admission, offline application will be received by DWO. After receiving the application, the DWO will verify the documents properly. if found eligible for availing financial assistance under this scheme, then sanction and forward the application in the Prescribed Format (Annexure B) by the DWO for processing of payment by this Deptt. with specific approval of the head of the Department.*

***(B) One time Financial Assistance for ST and SC students from economically deprived backgrounds for pursuing general (+3) degree course in any Government Institutions.***

- Any eligible ST/ SC student can make application to District Collector of the domicile district for receiving financial assistance under the scheme for pursuing general (+3) degree course in any stream in any Government College within the state in Prescribed Format (Annexure-B).
- Upon receipt of application, District Collector shall get examined the financial hardship/ distress condition of the family/ student to determine the requirement of extending financial assistance under the scheme.
- Once the District Collector recommends for financial assistance under the scheme, District Welfare Officer shall ascertain the quantum of one time assistance required to facilitate the student to complete the full course in the given institution. Requirement for other incidental expenses like purchase of books/study materials, coaching/ tutorial expenses may also be taken into consideration while finalising the quantum of one time assistance under this component.
- District Welfare Officer shall sanction for one-time financial assistance to the maximum extent of Rs.50,000/- (Fifty Thousand) only to eligible ST and SC students, on case to case basis, and forward the same to the

Department in the Prescribed Format with due approval of District Collector.

- The amount will be disbursed directly by the department in student's bank-account in DBT Mode. The student shall endeavour to seed his/ her bank-account with Aadhaar for hassle free payment.
- The student shall also be facilitated by District Welfare Officer to make on-line application in Odisha State Scholarship Portal (OSSP) under regular Post-Matric Scholarship Scheme as well for receiving post-matric scholarship over and above the assistance under Financial Assistance Scheme.

**Exclusion criteria:**

- Students from private management colleges/ institutions will not be covered.
- Student taken admission under management quota seat or seats/ courses under self-financing mode.
- Under component (a) of the scheme - Graduation/ post-graduation courses such as +3 Courses; PG courses – MA / M.Sc. / M. Com Paramedical, B.Ed, BBA, BCA etc. and Post-matriculation non-degree courses such as +2, ITI, Diploma, Vocational courses etc. will not be covered.
- Students who have availed scholarship under Top-Class education scheme of Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs will not be covered under the scheme.

This resolution will come in retrospective effect from December, 2022, for Component (A) in supersession of this Department Resolution No.22946/SSD dated. 21.11.2015. Component (B) will come into effect from financial year 2023-24.

The list of empanelled Colleges/Institutes to be covered under Financial Assistance Scheme to meritorious SC & ST students under Component A is attached at Annexure-A. The list will be revised from time to time for inclusion of any National Level Institutes/ State Government run medical & engineering Institutes, on case to case basis, with approval of authority.

**Order:-**Ordered that the Notification be published in the next issue of the Orissa Gazette and copies be supplied to Finance Deptt./ P & C Deptt./Higher Education Deptt./ SD & TE Deptt./ ST, SC Dev, M & BCW Deptt./ all Collectors/ all Dy. Directors (SSD)/ all DWOs for information and necessary action.
