GENERAL TERMS & CONDITIONS OF CONTRACT FOR SUPPLY OF BLANK ANSWER BOOKS TO BE DELIVERED AT THE EXAMINATION SECTION OF VSSUT, BURLA.

1. **EARNEST MONEY DEPOSIT (EMD).** All bidders are required to submit EMD of 20,000/- (Rupees Twenty thousand only) in shape of Demand draft drawn in favor of "VSSUT, Burla" payable at Burla. The EMD shall be in Indian Rupees.

NOTE: Non- submission of EMD or submission of less EMD than the desired one shall result in rejection of Bid. The EMI deposited against other Bids cannot be adjusted or considered for this Bid. No interest is payable on EMD



2. PROCEDURE FOR SUBMISSION OF BID.

The Bid shall be submitted in sealed envelopes as under

- a) Should contain the demand draft for the Earnest Money Deposit (EMD)
- b. Tender Document (as given in Annexure I, II, III) duly signed by the bidder at respective page and all photocopies of the necessary documents to be submitted along with the GST Regd. 3. TERMS AND CONDITION OF CONTRACT

Payment will be as far as possible made within one month from the date of receipt of bills triplicate and after 100% delivery of blank answer books, after deduction of tax as per rules through A/c Payce Cheque or to be transferred to his/her account through electronic system mode.
