Comments

As provided in Rule-20(9) of Odisha Local Fund Audit Rules-1951, Physical Verification of cash before commencement of audit i.e. on 17.11.22. Physical verification of unused Misc. Receipt Books has been done.

As per Rule 16 (iii) of Orissa Universities Accounts Manual, 1987 the Finance Officer shall verify at least once a month, the physical cash balance and give a dated certificate to that effect. Physical verification of Cash is important to check probable misappropriation in handling of Liquid cash. The C.O.F. has neither maintained the physical verification of cash balance nor maintained the minimum balance of cash as per OGFR rules. Any misappropriation happened due to retaining of heavy cash balance deviates the university Rules, for which C.O.F. is responsible.

The Local Authority is suggested to adhere the above Rules hence forth in order to ensure accuracy and transparency in maintenance of Accounts. As per Rule-57 of O.U.A. Rules-1987 physical verification of stock & stores should be conducted by an Officer being authorized by the Vice-Chancellor of the University at least once in a year. No such physical verification of the stock & stores of the University have been conducted.

As per University Manual Rule, the retention of cash balance in hand prescribed limit is Rs. 10000.00 provided that if the head quarter is situated at a place with no Treasury or Sub-Treasury, then money can be held to a maximum of Rs.20000.00. But on verifying & Checking of the Cash book, it is found that cash amounting to Rs. 157380.95 is kept in hand as hard cash contravening the rule. The above mentioned practice may be avoided in future. The physical cash verification was conducted on .17.11.2022 before the day's transaction. The local authority is advised to deposit Rs. 157380.95 in Bank and compliance to audit.

Retention of Heavy Cash in Hand

As per Rule -25(Note-1) of OGFR Rules - For this purpose, the heavy Cash will sent to the Departmental controlling officer, an extract from his accounts



Showing the amounts brought to credit in them in each month, which deviate the OGFR RULES by keeping money in hand no physical verification has been done by monthly instructed to local authority to be followed. The Local Authority is once again suggested to follow the above prescribed rule and to conduct periodical physical verification of Cash Balance to avoid every possibilities of misappropriation.

Comments

Consequence of Non-maintenance and Non-production of Statutory Records /Registers:

In contravention to Odisha University Account Manual Rules-1989, the following important registers were not produced for verification in spite of issue of objection memo on account of non-maintenance of these records by this Institution which are although being vital in nature signifies both financial and administrative repercussion.

- 1) Register of Abstract Receipt & Expenditure:- Non-maintenance of this register causes hindrances for computation of annual Income & expenditure position of a particular year at a glance as well as causes un-realistic figures in respect of preparation of Budget estimate.
- 2) D.C.B. Register of Student Collection:-Non-maintenance of this register results in unable to assess the Head of Account-wise collection made from the students as well as may leads to Short/Less collection of student fees which may cause loss to the University.
- 3) Fixed/Permanent Asset Register:-Non-maintenance of this register by the University will leave no scope to



asses and establish the asset position of this University either Capital or Revenue asset.

- 4) Work Register:- Non-maintenance of Work Register resulted no scope to watch the expenditure incurred for various construction works under taken by different line department as well as the University Authority fails to update with the information about the executed position of such works at any given point of time.
- 5) Quarter Allotment Register:-Non maintenance of the register may cause loss of University revenue by way of less/non-recovery of quarter rent as well as undue allotment.
- 6) SD/ EMD Register:- There is every possibility of multiple release of SD and escape of collection due from different executing agencies & firms.
- 7) Loan Register :-Non-maintenance of this register may create confusion in collection of loan amount availed by different employees and finally caused non recovery
- 8) Retention Money Register:-Non-maintenance of this register may facilitate the cause of temporary misappropriation of Cash.

However the above prescribed records and registers may be maintained henceforth and shown to next audit.

Due to such Non-maintainace the Actual Balance position of each Heads of Accounts of VSSUT, Burla could not be properly ascertained. As such ther may be encroachment of funds which could not be ruled out.

As calculated above, there is a huge difference of **Rs 90050479.55** between the cash book balances and the pass book balances as on dt. 31.3.2022. No step has been taken by the local authority to reconcile the difference in spite specific instructions of Govt on the score.

As per Letter No-15847/F dt. 27.4.13 of Finance Department, the DDO should maintain a register for reconciliation of receipts and disbursements of the fund. But in the University above instructions of Govt have been overlooked which indicates about the irregular state of maintenance of accounts.

However, the Local authority is advised to reconcile all those bank accounts and work out the details of such differences and produce the same before next audit. Till then the amount of **Rs 90050479.55** is kept under objection.

6.2:-Comments:-

Non-Conduct of Physical verification of Stock & Store during the year 2021-22:-

As per Rule-57 of O.U.A.Rules-1987 physical verification of stock & stores should be conducted by an Officer being authorized by the Vice-Chancellor of the University at least once in a year. It was observed that no physical verification of the stock & stores of the University have been conducted since long. Due to such irregular maintenance of the stock & stores accounts sufficient scopes have been created to mis utilise the stores. Hence attentions of University Authorities are invited in this regard and suggested to take the tangible steps as early as possible in order to resist the probable loss of the stock & stores of the University.

Irregularities in maintenance of Stock & Stores of the University:-

It is pertinent to mention here that as per Chapter-VII of the Odisha University Accounting Rules-1987 the detailed methods of purchase, accounting and verification of stock & stores have been elucidated. However it was noticed that the progressive stock positions of both permanent as well as consumable materials have not been worked out and exhibited in the stock registers soon after procurement and issue of every material from stores. The Dead Stock register of unused and damaged plants, machinery, furniture and fixtures etc. has not been maintained at all. Due to non-working out of the position of balance of each stock in registers it is not possible on part of audit to ascertain the exact position of each material purchased since inception and the exact balance available in the stores of the University.

During the course of audit it was disclosed that, out the outstanding advance as on 31.03.2022 as furnished above, Advance amounting to **Rs. 49980.00** related to the year 2020-21 has been remained un-adjusted till 31.03.2022 without necessary adjustment despite of more than one year has already been elapsed from the respective date of payment of such advances by 31.03.2022, which was highly irregular & defeating the very purpose of such advance. In this connection it is worth-while to be mentioned here that, As per the instruction issued by Govt. vide G.O.No.XIV-Aud-2221/F Dt.8.03.2002 of Finance Dept. Govt. of Odisha & Lr. No-15179/DLFA Dt. 28.09.13 of DLFA, BBSR the advances outstanding for a period of more than one year



without valid reason are treated as loss to the Govt. & thus required to be suggested for recovery from the concerned advance holder as well as from the authorities who sanctioning such advances.

In this regard, the local authority is asked to furnish the reasons that, why such advances were kept unadjusted despite of about two years has already been passed from the date of payments & what such steps has been taken against the erring officials for necessary adjustment till date.

Comments on Non-utilisation /Low spending efficiency of Grants:-

It could be noticed from the Receipt & Utilisation of Grants for the period 2021-22 that, Grants amounting to Rs. 35,65,79,712.49 was remained un-spent as on 31st March 2021 resulted irregular parking of Govt. Grant which was contrary to Govt. guidelines/Principles of financial management.

Hence it would be seen from the table furnished above where the 52.70 % of grants was spent, it was construed that the pace of utilization of grants during the period covered under this audit in some components like (1) RUSA, (2) Const. of Innovation centre, (3) Research Project under DST, (4) Research projects under SRIC & (4) Project



grants of CSIR/UGC the financial achievement was not satisfactory. It was ascertained that, no sincere follow-up action has been initiated by the University Authorities for proper utilization of such grants within the stipulated period to provide benefit for the academic development/ research activities of the students for which it was meant for. However in this regard it would be mentioned here that as per Govt. instructions issued from time to time in which it was always stressed upon for prompt utilisation of grants within the corresponding financial year or within the prescribed period as per the sanction orders instead of parking the allotted amount in the institution fund on account of non/less utilisation, which was quite irregular and defeating as far as the intention of the sanctioning authorities are concerned & also in order to avoid the following consequences that may resulted, such as:

- a) Un-authorised retention/parking of Govt. money which may seriously affect the ways & means position of Govt.
- b) Possibilities of Re-appropriation/Mis-utilisation in different heads of expenditure other than the sanctioned purposes.

However the University Authority is suggested to initiate sincere steps either for the relevant utilisation of the unspent grants for the sanctioned purposes by obtaining fresh sanction from the appropriate authorities or may surrendered the balance un-spent amount (If there is no scope of utilisation) to the respective sanctioning authorities at the earliest as per the provision contained in Appendix-10 of OGFR(Vol-1) & as required under Rule-171(3)(a) of OGFR.

- 2. Rs 1500.00 where annual income exceeds Rs. 1,60,000/- but does not exceed Rs.3,00,000/-
- 3. Rs 2500.00 where annual exceeds Rs. 3,00,000/-

But in case of following employee though income including salary exceeds Rs 160000.00 (Rs. 15000.00 x 12) PT is not deducted Rs. 1500.00 per annum.

Suresh Chandra Nayak, JE, Electrical Maintenance Rs. 15000.00 X 12 = Rs. 180000.00

So Rs. 1500.00 is needs to be recovered from Suresh Chandra Nayak, JE and compliance reported to Audit.

On issue of Objection memo the local authority recovered the amount from the concerned JE vide MR no. 30647/03.05.2023." the MR is duly verified and the Para is settled

13.5 - Non recovery of Charges for use of staff Cars from residence to office & back resulting a loss of Rs 33600.00 to the university fund. POM 9 Page-17 to 18

33600.00 to the university fund.

(F.D. no 19541/F/dt.13.07.2016

As per Finance deptt. resolution no.19541/dt 13.07.2016 para (i) 3, the rate of recovery of charges for use of staff cars for journey from residence and back by Govt.officials of university officials is Rs 1400.00 per month.

On checking of pay acquaintance rolls with reference to Log book of vehicles, it is noticed that the officers of VSSUT like Registrar & COF using office vehicles are not paying any charges towards use of office vehicle for their journey from residence to office i.e. from Sambalpur to Burla.

But as per the above Govt.circular the Registrar & COF should either deposit the amounts of Rs 1400.00 in each month or should be debited from their monthly salary.

On Checking of Hostel account of Arundhati Hall of Resident (Development cash book) having passbook account number- 80622213412 (Canara bank), It is observed that on 23.11.2021 by self cheque no-347495, amount of Rs. 10000.00 withdrawn for day to day activity but in the receipt side of cashbook in cash section (page number no-13) Rs. 10000.00 is booked but due to totalling mistake Rs 9000.00 is taken less in receipt side (Totalling Rs 48433.00 is booked instead of totalling amount Rs 57433.00).

Therefore there is a mistake of Rs. 9000.00 in cash due to totalling mistake in cash book.

Audit may be intimated why the amount will not be surcharged from the erring officials.

Is banned. Violation of these instructions will result in fixation of personal responsibility on the Officer engaging such persons and also on persondisbursing the wages to the concerned persons.

As such why the sum of **Rs 6, 42,725.00** towards payments to DLRs should not be treated as Irregular & unauthorised and recoveredfrom responsible officials may be clarified to Audit.

The budget position of the undertaking will be communicated to thel&PRDeptt. at the beginning of the year for keeping on effective watch on release of advertisements. Such budget provision must be communicated with the first advertisement of the year if not communicated earlier. I&PR Deptt. Shall communicate approved rate in-respect if each news papers/periodical to all such advertisers in order to enable them to make payment directly to the news papers under intimation to I&PR Deptt.

As per clause 8.14 of the guideline communicated by the Finance Department, a suitable provision was to be incorporated in the terms and conditions of the contract for claiming liquidated damage at 0.5% of the price of the delayed delivered goods (or delayed services) per week or part thereof with maximum of 10% to take care of delays in supplies and performance, for which the supplier is responsible.

During the course of audit of VSSUT it was noticed that while procuring of Stock materials through tender process and award of contract for procurement of goods a total sum of Rs.140709.00 has been given undue favour to the supplier due to non-including of clause for levy of liquidated damages in supply as detailed below.

It is worthwhile to be mentioned below the relevant guiding principles for Deposit works & Mode of settlement of accounts by the client i.e. in favour of which the execution has been Undertaken by other executing agencies as prescribed in the CPWD code/CVC guidelines/ General Financial Rules for reference on the part of the Local



authority:

Rule-3.4 Realization of deposits:

- (a) Whenever a deposit work is to be undertaken, the deposit should be realised before any liability is incurred on the work; i.e. 1% of the anticipated project cost should be realised before preparation of preliminary estimates. In addition to the outlay on the work in the preliminary estimate, departmental charges at such percentages as are prescribed by the Government of India from time to time shall also be realized in advance. No interest will be allowed on sums deposited from any source.
- (b) In the case of deposit works of autonomous bodies which are financed entirely from Government grants, and from whom receipt of deposits is assured, 33-1/3% of the estimated cost of the work or 10% of the estimated cost of the work at the time of requisition/issue of A/A & E/S and balance amount i.e. 23-1/3% of the estimated cost of the work before award of work may be got deposited in advance. Thereafter, the expenditure incurred may be got reimbursed through monthly bills simultaneously with rendering of monthly accounts on the progress of work. The deposit of 33-1/3% obtained as mentioned above should be retained for adjustment against the last portion of the estimated expenditure. (Modified vide OM DG/MAN/288 dt.06.09.2013)(Important)
- (c) Where delays are experienced in obtaining deposits, and where the expenditure has to be incurred out of the 33-1/3% reserve to keep the works going, the matter should be brought to the notice of Superintending Engineer/Chief Engineer promptly for taking up the matter with the client. No expenditure shall be incurred on deposit works out of CPWD grants and vice-versa.
- (d) To enable the client to provide additional funds in time whenever the expenditure is anticipated to exceed the preliminary estimate figure, a revised preliminary estimate should be submitted to the client well in time during the execution of work.
- (e) Where a client has defaulted in making the required deposit, and where the outstanding amount exceeds Rs.10 lakhs, or where the works outlay is predominantly for purchase of capital equipments and machineries, the entire deposit including departmental charges should be realized in advance.
- (f) In no case deposits received from a client department for its work should be diverted to other works.
- (g) The client is to be clearly made to understand that the Central PWD does not bind itself to complete the work within the amount of the preliminary estimate, and that they should agree to pay for the excess expenditure that may occur. An acknowledgement of this clear understanding shall be obtained from the client before the deposit work is taken in hand.
- (h) The Executive Engineer should ensure that at any time during the progress of the work, the expenditure is not more than the deposits received for the work. Where the Executive Engineer is doubtful about the timely receipt of deposits, he should notify the client that if further deposit is not received, the work would be stopped, and any contractual liability arising out of such stoppage of work will be borne by the client. He should also bring this to the notice of his higher officers for taking up the matter with the client.
- (i) While submitting preliminary estimates for deposit works for obtaining administrative approval and expenditure sanction, a copy of the terms and conditions under which the works would be taken up by CPWD, as given in Appendix 3, should also be enclosed.

Rule-3.6 Execution of deposit works and settlement of accounts:

- 1. With regard to design, estimate and execution of work, instructions as contained above should be followed. The scope of work should not be altered without written permission of the client.
- 2. The Executive Engineers shall send to their Accounts Officers every month the Statement of Expenditure in Form CPWA 65A along with the Schedule of Deposit Works in Form CPWA 65, for transmission to the concerned client after verification. These should indicate against each work, the amount of the estimate,



- the total deposit received and the expenditure incurred, both during the month and up to date. The Executive Engineers should invariably endorse a copy of this Statement to the concerned client.
- 3. The Executive Engineers should regularly send these statements to enable the adjustment of outstanding amounts in the books of the clients, and to avoid difficulties in reconciliation of accounts relating to deposit works after passage of time.
- 4. The Executive Engineers should also send a quarterly report to the clients showing the amount deposited and the expenditure incurred against each of the works for settlement of accounts.
- 5. It is necessary that the Executive Engineers settle their accounts against the deposit works expeditiously so that the amount in the books of the audit as well as the client does not remain unsettled for long.

In this connection the Local authority is requested to furnish the certified copy of Estimate, monthly statement of Expenditure regarding Progress of Deposit works along with amount of UC obtained from the concerned Executing Agencies along with Permanent asset register & statement of settlement of accounts against deposit outstanding upon the concerned Executing Agencies as on 31st March 2022.

In response to audit objection issued on this regard, the local authority did not furnish any reply. As such on account of non-production of the requisite documents by the M.E, Civil Maint., the utilisation details of such deposited funds at various executing agencies during the year.2021-22 could not be ascertained in audit & for which Rs.- 16,39,80,350.00 is kept under objection due to such lapses & relevant records may be produced to next audit and compliance reported.

However It is advised to local Authority to maintain the register in employee-wise & the details of NPS collection and deposit amount for Rs.68628424.00 which may be shown to next audit.

19.6 - POSITION OF SD/EMD FOR THE YEAR 21-22

Basing upon the closing balance derived for the last year as well as from the Security deposit/EMD shown collected and released through paid vouchers of University account cash books during the year 2021-22, the position of S.D /EMD was worked out of which an abstract position is furnished below:

henceforth to watch the fairness of release as well as to restrict multiple refunds of SD/EMD against single cases.

PARA: 20 RESULT OF AUDIT AND CONCLUSION 20.1 - GENERAL REMARKS:-

On completion of audit of this University account for the financial year 2021-22 it was concluded that,

- 1. The state of maintenance of cash books was not seems satisfactory,
- 2.Details of closing balance at the end of the month as well as at the year end was not classified,
- 3. Abstract of Head-wise Receipt & Expenditure was not worked out,
- 4.Reconciliation of Bank account balances was not worked out either at the end of the month or year,
- 5.Crores of rupees in shape of Fixed deposit has been kept outside the cash book balance,
- 6.Scheme-wise Grant/UC register was not maintained,
- 7. Most of the development works were shown executed through splitting up manner,
- 8.Register of student collection/DCB register was not at all maintained.
- 9.Expenditure were incurred only basing upon the approval of BOM, without approved budgetary provision & also no step was seems taken for approval of the budget from the Govt.in ET&ET dept.
- 10.Despite of availability of University owned LMVs, sizeable amount was spent towards hire charges of private vehicles for luxurious means.
- 11. The techno-economical viability of the tendered works were not assessed properly before finalization of bidder.
- 12. Huge expenditure was incurred for BOM meeting/Lecturers interview without any limitation by means of the plea that, "BOM was approved such amount".
- 13. Although crores of rupees was spent towards construction/repair of staff quarters, but no such sizable amount towards quarter rent was recovered on account of wrong assessment of Qr. rent.
- 14. Advances were not promptly adjusted within limited time resulted lagging of un-adjusted advance from years together.
- 15. No action was taken towards sale proceed of un-used computer accessories/furniture & fixtures, despite huge purchase of fresh materials every year.
- 16.No such Work Register/Asset Register was maintained to watch the creation of capital assets in a particular year as well the genuineness of renovation & repair.
- 17. Non-cooperation & Non-attendance to audit was a habitual feature of the staffs of this University.

Keeping in view of the above, the Local Authority was once again suggested to be vigil about the aforementioned



facts & may initiate sincere

As a result of this Audit transactions involving a sum of Rs 277376490.55 are held under objection which include an amount of Rs 49980.00 suggested for recovery. Besides, a sum of Rs 21568 was recovered at the instance of audit. The details are furnished in the following tables.
