The quotations will be opened on 27.08.2013 at 3.30 P.M. in the office of the VC/Registrar in the presence of Tenderer or their authorized representative, if any.
- 2. Tender received after the due date & time is liable to be rejected. Tenders by FAX/ e-mail will not be entertained.
- 3. **Cost of** Tender **Documents:** The Tender documents can be obtained by furnishing request letter from the cash counter of the university on payment of Rs. 500/-(Rupees Five Hundred Only)( Non-refundable) .Firms who have downloaded documents from our website, have to deposit a DD of same amount in favor of COF, VSSUT, Burla payable at SBI, Burla along with Tender.
- 4. **E.M.D.:** The Tender along with an A/C payee D/D for the amount of @1% of the quoted value is to be submitted in favor of VSSUT, Burla payable at SBI, Burla(Code: 2034) towards EMD amount.

Balance 10% of the order value would be payable to the Firm on expiry of warranty period. All payments will be released based on separate invoices submitted to the university by the supplier.

- 10. The suppler must submit valid up-to-date VATCC & ITCC along with bill before release of payment.
- 11. The COF, VSSUT, Burla reserves the right to cancel the work order if the equipments supplied & installed fail to meet the specifications mentioned in the order.
- 12. The COF, VSSUT, Burla reserves the right to call the firms and to conduct negotiations, if necessary.
- 13. Any loss/damage during transit will be at the cost of the Firms.
